

# HEC – Health Workforce Innovation Challenge Official Terms and Conditions

## 1. About HEC:

Healthcare Excellence Canada ("**HEC**") is a not-for-profit organization primarily funded by Health Canada. HEC collaborates with people and organizations across the country to spread innovations, build capability and catalyze policy changes that improve healthcare safety and quality. The views expressed herein do not necessarily represent the views of Health Canada.

## 2. Challenge streams:

For the purposes of the HEC Health Workforce Innovation Challenge (the "Challenge"), HEC is challenging healthcare innovators to share and grow their approaches to improving retention and support of the current workforce in either of the following two (2) streams (each a "Stream" and collectively the "Streams"): (i) northern and remote stream, which encompasses organizations that provide publicly funded or private health and/or social services in the Provincial and Territorial North as defined below ("Stream 1"); or, (ii) other stream, which encompasses organizations that provide publicly funded or private health and/or social services within Canada ("Stream 2").

The "**Provincial and Territorial North**" is defined as the following regions in Canada: (i) the Yukon, Northwest Territories and Nunavut territories; and (ii) the northern subregions of the provinces of British Columbia, Alberta, Saskatchewan, Manitoba, Ontario, Québec, and Newfoundland and Labrador, as set out in **Schedule "A"** of these Terms below.

# 3. Eligibility of teams, team leaders, sites, site leaders and team members:

Participating organizations in the Challenge must participate as an eligible Team (defined below). Each Team must, at minimum, be comprised of: (i) one (1) Team Leader (defined below); (ii) one (1) or more Lead Sites (defined below) and a Site Leader (defined below) of each such Lead Site; (iii) one (1) Team Member (defined below) who is a senior officer or director from the Lead Site's organization; (iv) one (1) Team Member who is a licensed or regulated health or social care provider and/or who works as a front-line staff for the Lead Site's organization; and (v) one (1) Team Member who is a patient and/or family representative of the Lead Site's organization, involving those who experience and need care. A Team may (but is not required to) also consist of additional Team Members and/or one (1) or more Supporting Sites, as set out below.

### **Teams and Team Leaders:**

For the purposes of the Challenge, a team (a "Team") must be created and registered on the Challenge portal (<u>https://hec-esc.smapply.ca/</u> – the "**Portal**") by an individual who is designated as the Team's leader (a "Team Leader"). The Team Leader will: (a) be the primary point of contact for HEC and for Team Members throughout the Challenge; (b) act as coordinator for all of the Team's activities (including, but not limited to, data submission before the appropriate deadlines, cooperation in any verification process and Award distribution); (c) be responsible for the Team's Registration (as defined below) and ensuring that all Sites, Site Leaders and required Team Members register to the Portal in accordance with these Terms; and (d) agree to receive correspondences on behalf of the Team at the email address provided at Registration, which serves as the primary mechanism through which HEC communicates with the Team. Each Team Leader is required to register and identify a minimum of: (a) one (1) Team Member (as defined below) who is a senior officer or director from the Team's Lead Site organization, demonstrating endorsement; (b) one (1) Team Member (as defined below) who is a licensed or regulated health or social care provider and/or who works as a front-line staff for the Team's Lead Site organization and (c) one (1) Team Member (as defined below) who is a patient and/or family representative of the Team's Lead Site organization, involving those who experience and need care.

To be eligible, a Team Leader must: (a) be a resident of Canada; (b) have reached the legal age of majority in their province or territory of residence; (c) have the unencumbered authority, authorization and permission from each Site (as defined below), Site Leader (as defined below) and Team Member (as defined below) associated with their Team to: (i) register any such Site (as defined below), Site Leader (as defined below) and Team Member (as defined below), Site Leader (as defined below) and Team Member (as defined below) associated with their Team to: (i) register any such Site (as defined below), Site Leader (as defined below) and Team Member (as defined below) for the Challenge as part of their Team, (ii) provide to HEC any and all required information and/or documentation that relates to such Site, Site Leader and Team Member for the purposes of administering the Challenge in accordance with these Terms, and (iii) legally bind such Site, Site Leader and Team Member including, without limitation, to these Terms and to any other required documentation as contemplated in these Terms; (d) not be ineligible to participate in accordance with the exclusions in Section 4; and (e) agree to be legally bound by these Official Terms and Conditions (the "Terms") and to any other required documentation as contemplated in these Terms.

### Sites and Site Leaders:

For the purposes of the Challenge, a lead site (a "**Lead Site**") must consist of an organization that provides publicly funded health and/or social services in Canada. Regulated public and private organizations and/or charitable and non-profit organizations providing health and social care related services in Canada are also eligible.

For the purposes of the Challenge, a supporting site (a "**Supporting Site**") consists of a private (for-profit) organization providing health and social care related services. To be eligible to participate in the Challenge, a Supporting Site must participate with (and be registered through a Registration (defined below) as participating on the same Team as) a Lead Site that has agreed to participate with such Supporting Site.

To qualify for the Challenge, any Lead Site and Supporting Site (each, a "**Site**") must designate one (1) individual (a "**Site Leader**") who must be a representative of the Site and meet all other Site Leader eligibility requirements set out below.

Further, the Site Leader must: (a) be a resident of Canada; (b) have reached the legal age of majority in their province or territory of residence; (c) not be ineligible to participate in accordance with the exclusions in Section 4; (d) agree to be legally bound by these Terms and to any other required documentation as contemplated in these Terms; and (e) have the unencumbered authority, authorization and permission to: (i) legally bind the Site to these Terms and to any other required documentation as contemplated in these Terms; and (ii) submit any Data (as defined below in Section 8) on behalf of the Site to HEC, and otherwise provide to HEC any and all other required information and/or documentation that relates to the Site, for the purposes of administering the Challenge in accordance with these Terms.

A Site may participate on more than one Team, however the Data from one Site may not be used by more than one Team for a particular Stream. For the avoidance of any doubt, this means that Data from the same Site relating to a particular Stream cannot be used by more than one (1) Team in this Challenge. There is no limit to the number of Sites on a Team.

### **Team Members:**

A Team Leader can also invite other individuals to participate on their Team (each a "Team Member" and collectively the "Team Members") – provided each such Team Member: (a) is a resident of Canada; (b) has reached the legal age of majority in their province or territory of residence; (c) agrees to be listed on the Portal as a member of the Team; (d) is not ineligible to participate in accordance with the exclusions in Section 4; and (e) agrees to be legally bound by these Terms and to any other required documentation as contemplated in these Terms.

An individual may be a Team Member on more than one Team. There is no limit to the number of Team Members on a Team.

## 4. Additional eligibility rules:

### Excluded from participating - individuals:

For the purposes of this Challenge, an individual is not eligible to participate if: (a) they is a director, officer, employee, representative or agent (or living with any such persons, whether related or not) of HEC or any other individual(s), entity or entities involved in the development, production, implementation, administration, judging or fulfillment of the Challenge (collectively, the "**Challenge Parties**"); and/or (b) they does not otherwise satisfy the requirements set forth in these Terms (as determined by HEC in its sole and absolute discretion).

### **Excluded from Participating – Sites:**

For the purposes of this Challenge, a Site is not eligible to participate if it: (a) is located outside of Canada; and/or (b) is a department or agency of the Federal Government of Canada; and/or (c) does not otherwise satisfy the requirements set forth in these Terms (as determined by HEC in its sole and absolute discretion).

### Verification:

HEC reserves the right, in its sole and absolute discretion, to require proof of identity and/or eligibility (in a form acceptable to HEC) for the purposes of verifying eligibility to participate in the Challenge. Failure to provide such proof to the complete satisfaction of HEC within the timeline specified by HEC may result in disqualification in the sole and absolute discretion of HEC.

Further, HEC reserves the right, in its sole and absolute discretion at any time, to disqualify any Team, Site, Team Leader, Site Leader and/or Team Member- including, but not limited to, if, for example, HEC determines that the Team, Site, Team Leader, Site Leader and/or Team Member (as applicable) to participate in (or continue to participate in) the Challenge could bring HEC into public disrepute or in any way impact the good standing or reputation of HEC in the eyes of the general public. HEC's decisions on all matters arising in this regard shall be final and binding without right of appeal.

At HEC's sole and absolute discretion, a Team may be required to submit video demonstrations during the Challenge to validate adherence to these Terms. Demonstration videos (or equivalent, as designated by HEC) must meet the requirements deemed to be appropriate by HEC based on the circumstances.

ANY INDIVIDUAL OR ENTITY DEEMED BY HEC TO BE IN VIOLATION OF HEC'S INTERPRETATION OF THE LETTER AND/OR SPIRIT OF THESE TERMS FOR ANY REASON IS SUBJECT TO DISQUALIFICATION IN THE SOLE AND ABSOLUTE DISCRETION OF HEC AT ANY TIME.

### **Conflicts of Interest:**

By participating in the Challenge, each Team Leader, Site Leader (on their own behalf and on behalf of their Site) and Team Member is signifying their agreement that they have read and understands HEC's <u>Conflict of Interest Policy</u> (including, but not limited to, rules regarding the eligibility of HEC employees, directors, registrants and agents). Sites from which any members of HEC's Board of Directors, or Foundation agents or employees, receive remuneration are eligible to participate in the Challenge. All participants must fully disclose any relationship with members of HEC's <u>Board of Directors</u>.

# 5. Team registration:

Registration will open on June 27, 2023 at 12:00:00 a.m. Eastern Time ("**ET**") and close on April 30, 2024 at 11:59:59 p.m. ET (the "**Registration Period**"). Registration for the Challenge will remain open throughout the Registration Period. Each Team Leader will be required to complete the registration process for their Team through the Portal (the "**Registration**"). In addition to any other information specified on the Portal, the Team Leader will be required to submit the:

- name and contact information of the Team Leader;
- name and contact information of each Site and its Site Leader that will be associated with the Team;
- name and contact information of each Team Member that will be associated with the Team, appropriately identifying (a) a senior officer or director within the Lead Site, demonstrating endorsement; (b) a licensed or regulated health or social care provider and/or who works as a front-line staff for the Lead Site; and (b) a patient and/or family representative of the Lead Site;
- Stream applicable to the Team; and,
- person or organization (business name) who will receive Award(s) (as defined in Section 10) if successful.

The Team must also provide the following required information by the timeline specified in order to be eligible to qualify for the Challenge:

- at the time of Registration, a description of the current OR intended intervention(s) or pathway(s), effectively representing those components key to achieving improvements within one (1) or more of any of the six (6) Indicators set out in Table 1, Section 7; and,
- within sixty (60) days of completing Registration, an Outcomes Plan (defined below) confirming the Indicator or Indicators and Population Reach (defined below) that the Team has selected for the Challenge, as further detailed in Section 7. During such sixty (60) day period, Teams may seek guidance as needed from HEC staff and coaches to help define and confirm their outcomes Indicators.

**IMPORTANT NOTE:** A Team can only be registered one (1) time in the Challenge in one (1) Stream at Registration.

After all required information has been submitted through the Portal by the Team Leader, the Team will be registered in the Challenge (subject to the verification and approval of HEC in its sole and absolute discretion). If a Team is deemed qualified by HEC, as determined in its sole and absolute discretion, the Team Leader will be notified accordingly.

## 6. Changes to team composition after registration:

After completing the Team's registration in accordance with Section 5, the Team Leader will be permitted to make the following changes to the composition of their Team throughout the Challenge through the Portal:

- Add new Team Members provided any such new Team Members satisfy the eligibility requirements as set forth in these Terms;
- Remove Team Members;
- Add new Sites provided any such new Sites satisfy the eligibility requirements as set forth in these Terms; and/or
- Remove Sites.

In addition, a Team Leader may assign their designation as Team Leader to another Team Member or Site Leader – provided that such Team Member or Site Leader (as applicable) satisfies the eligibility requirements to become a Team Leader as set forth in these Terms.

## 7. Challenge indicators and population reach:

For the purposes of the Challenge, Teams will have six (6) thematic areas from within which to identify their outcomes indicator(s) (each an "Indicator" and collectively the "Indicators") designed to help measure improvement within the applicable Stream. Based on the Stream and Indicator(s) identified by the Team, each Team may track and submit core measures of improvement that fall within the definitions outlined below in Table 1 (the "Reported Data") (the submission of such Reported Data is further described in Section 8 below).

Within sixty (60) days of completing Registration, Teams must identify and submit an outcomes measurement plan (the "Outcomes Plan") - using the template provided by HEC with formatting and word count specifications - through the Portal, identifying: (a) one (1) or more outcomes Indicators relevant to their innovation (per Table 1, in this Section 7); (b) the target provider/interprofessional healthcare worker group population to be reached (the "**Population Reach**"); and, (c) the measurement and reporting methods, with commitment to anonymized quarterly reporting (per Table 2, Section 8). If more than one (1) outcomes Indicator is identified, the Team must select a primary outcomes Indicator (the "Primary Indicator") for the purposes of the quarterly data submission (Per Section 8, Table 2) and any outcomes-based awards, which includes (but not limited to) the Mid-term Retention Progress Award and Overall Retention Achievement Award (Per Section 11). If only one (1) Indicator is identified by a Team within its Outcomes Plan, such Indicator will automatically be designated by HEC as the Team's Primary Indicator for the purposes of the quarterly data submission (Per Section 8, Table 2) and any outcomes-based awards, which includes (but not limited to) the Mid-term Retention Progress Award and Overall Retention Achievement Award (Per Section 11).

IMPORTANT NOTE: For Teams Registering before October 16, 2023 at 11:59 p.m.

ET, such Teams may meet the Outcomes Plan requirements above (including, without limitation, submitting the Population Reach and, as applicable, Primary Indicator) by participating in Mini-Challenge #1 as described in Section 11 (participation in Mini-Challenge #1, for certainty, will allow for the eligible submission of the Team's Outcomes Plan, including without limitation the Team's Population Reach and, as applicable, Primary Indicator). For Teams that complete Registration after October 16, 2023, such Teams are not eligible to participate in Mini-Challenge #1 however must still meet the Outcomes Plan (including without limitation the Team's Population Reach and, as applicable, Primary Indicator) requirements described above within sixty (60) days of completing such Registration

# 8. Reporting Data:

**IMPORTANT NOTE:** Teams are not required to submit Baseline Data or Reported Data, as set out below, in order to be eligible to participate in the Challenge. However, in order to be eligible for a Mid-Term Retention Progress Award and Overall Retention Achievement Award (each defined below), a Team must submit Baseline Data or Reported Data, as set out below. For greater certainty, if a Team does not submit Baseline Data or Reported Data, as set out below, such Team will not be eligible for a Mid-Term Retention Progress Award or Overall Retention Achievement Award, however, may be eligible for other Awards in the Challenge based on the criteria set out in Section 11 below.

### **Baseline Data:**

In order to be eligible for a Mid-Term Retention Progress Award and Overall Retention Achievement Award (each defined below), a Team will be required to provide baseline data (the "**Baseline Data**") in relation to the Primary Indicator identified by the Team (Per Section 7) in accordance with the reporting schedule set forth in Table 2 below. If a Team's Registration is completed before July 31, 2023, then the earliest Baseline Data eligible for that Team will relate to July 2023. For any Registrations completed in a subsequent month, the earliest qualifying Baseline Data will be the calendar month of which the Team's Registration was completed in accordance with these Terms.

Baseline Data must include, for the month of Registration (with the earliest qualifying being July 2023):

• Current outcomes as they relate to the selected Primary Indicator, measured and reported per the described measurement and reporting methods as shown by the Team by submission of their Outcomes Plan in accordance with Section 7.

For Teams that do not yet have the Baseline Data available at Registration (for example, in the case of a new initiative), the first earliest month included in their quarterly data submission will count as the Team's Baseline Data, including the first Reported Data from that team (as per Table 2 of this Section 8).

### **Reported Data:**

In order to be eligible for a Mid-Term Retention Progress Award and Overall Retention Achievement Award (each defined below), a Team will be required to track and submit progress against their Primary Indicator in accordance with the reporting schedule set forth in Table 2. All Reported Data must be submitted by the Team Leader through the Portal. In the event a Team fails to submit Reported Data in accordance with these Terms, the applicable Reported Data will not be counted towards an Award and (in order to remain eligible for Award(s) that require Reported Data) the Team will still be required to report once available for the purposes of calculating potential future Awards.

All Baseline Data and Reported Data (collectively, "Data") is subject to verification and audit in accordance with Section 9.

## 9. Verification and Audit of Data:

HEC may verify, or appoint an auditor to verify, any Data provided to help ensure compliance with these Terms at any time and for any reason. If any Data cannot be verified to the complete satisfaction of HEC, then the applicable Team Leader will be informed accordingly and will have three (3) business days to address the issue to the complete satisfaction of HEC. When addressing an issue relating to Data, HEC will determine, in its sole and absolute discretion, the appropriate course of action – which may include, but is not limited to, disqualifying the Team in question from the Challenge, or taking whatever other action HEC deems to be appropriate in the circumstances by exercising all rights and remedies permitted by law.

## 10. Awards:

For the purposes of this Challenge, there will be a total of \$750,000 CAD in awards (each, an "**Award**" and collectively the "**Awards**") available to be earned in accordance with these Terms. The amount of each Award is set forth in Section 11 of these Terms.

**IMPORTANT NOTE:** There is no limit to the number of Awards a Team may earn in accordance with these Terms. However, a Team must achieve a minimum threshold (the **"Threshold"**) in order to be eligible to receive an Award. The Threshold applicable to each Award is as set forth in Section 11 of these Terms. Further, a Team is only eligible to earn a maximum of one (1) Innovation Kickstart Award and one (1) Collective Impact Achievement Award in the Challenge.

Once confirmed by HEC in accordance with these Terms, Awards will be deposited into

an account designated by the Team Leader at Registration. The account must: (a) reside at a Canadian financial institution; (b) be an interest-bearing account; and (c) be in the legal name of the Team Leader (or associated business name) or Site, as provided at Registration.

The Team Leader will be solely responsible for the administration and disbursement of any and all Awards received by the Team. HEC will not intervene in any decision(s) and/ or dispute(s) regarding the allocation of an Award among individuals and/or entities who may or may not have participated as part of the Team in the Challenge.

All Awards provided by HEC pursuant to this Challenge are inclusive of all applicable taxes.

HEC may require, in its sole and absolute discretion, that the Team Leader of a Team that is eligible to receive an Award first sign and return HEC's form of declaration and release prior to the Team being confirmed as an Award recipient.

# 11. Award determination process:

### Innovation Kickstart Awards:

Upon successful Registration in accordance with Section 5, qualifying Teams will be entered into one (1) or more Draws for Innovation Kickstart Awards (the "**Innovation Kickstart Award(s)**") per the schedule outlined in Table 3 (Section 11).

There will be four (4) Draws throughout the Challenge as outlined in Table 3 of this Section 11 below. At the start of the Registration Period, a total of forty-five (45) Innovation Kickstart Awards are available in the Challenge (there are ten (10) or fifteen (15) Innovation Kickstart Awards available per Draw, as outlined in Table 3 of this Section 11 below). The total number of Innovation Kickstart Awards available in the Challenge will decrease as such Awards are claimed in accordance with these Terms.

To be eligible, Teams that meet the eligibility requirements to participate in the Innovation Challenge and complete a Registration during the Registration Period in accordance with these Terms, all as determined by HEC in its sole and absolute discretion, will each receive one (1) ballot to be entered into a Innovation Kickstart Award draw (a "Innovation Kickstart Award Draw"), based on the date that such Registration is received by HEC, for the chance to receive an Award of \$2,000.

On each of the Innovation Kickstart Award Draw dates (each, a "**Draw Date**") listed in the following Table 3 at approximately 12:00 p.m. ET in Ottawa, Ontario, HEC or its designated representative will perform a random draw from among all eligible ballots received in accordance with these Terms prior to the close of the corresponding draw deadline (each, a "**Draw Deadline**") listed in Table 3 below. All unselected ballots in a Innovation Kickstart Award Draw will carry over into any subsequent Innovation Kickstart Award Draw(s) (as determined by HEC at its sole discretion). For certainty, a Team that is drawn as an eligible recipient of a Innovation Kickstart Award is not eligible for any remaining Innovation Kickstart Draws and such Team's ballot will not carry over into any subsequent Innovation Kickstart Draw(s). Odds of being selected depend on the number of eligible ballots received prior to the close of the applicable Draw Deadline.

Recipients of the Innovation Kickstart Awards will be drawn in accordance with the schedule outlined in Table 3 (Section 11).

# Shared Reach Challenge and Collective Impact Achievement Awards:

Starting on August 1, 2023 at 12:00 a.m. ET and running until June 3, 2024 at 11:59 p.m. ET, the Shared Reach Challenge (the "**Shared Reach Challenge**") will be open to participating Teams to contribute data pertaining to a collective Reach Indicator ("**Reach Indicator**") related to interprofessional healthcare worker reach, as outlined in Table 4 (Section 11). As a collective, participating Teams will contribute monthly data, in accordance with the quarterly reporting schedule set out in Table 2, Section 8 above, with the goal of reaching or exceeding the target number (the "**Target Number**"), as determined by HEC at its sole and absolute discretion and published on the Portal by HEC by February 2024. The Target Number is a specific quantitative goal or outcome that Teams, together as a collective group, aim to achieve in a certain timeline.

Participating Teams provide data (numbers) to support increased reach over the course of the Challenge:

• Interprofessional reach (health workforce staff), for example number of staff impacted.

During the Shared Reach Challenge period set out above, for every one (1) month of eligible data submitted by a Team (in accordance with the reporting schedule set out in Table 2, Section 8 above)—up to a maximum of ten (10) months total — the Team will receive one (1) ballot to be entered into the random Shared Reach Challenge draw for the chance to receive a Collective Impact Achievement Award (the "Collective Impact Achievement Awards Draw"). Therefore, Teams are eligible to receive a maximum of ten (10) total ballots in the Shared Reach Challenge for the chance to receive a Collective Impact Achievement Awards Draw will take place on or around June 12, 2024 in Ottawa, Ontario at approximately 12:00 p.m. ET, on the condition that the Target Number was met or exceeded.

Each Team associated with a ballot drawn in accordance with the schedule outlined in Table 5 (Section 11) will be eligible to receive a Collective Impact Achievement Award (each, a "**Collective Impact Achievement Award**"). There are eight (8) Collective Impact Achievement Awards available.

### **Innovation Description Awards:**

By September 15, 2023 at 11:59 p.m. ET, Teams can submit a brief Challenge story (a **"Story**") that introduces their Team Leader, patient and/or family representative, licensed or regulated health or social care provider and/or who works as a front-line staff and senior officer or director (as set-out in Section 3) and demonstrates: (a) their current work underway relevant to their chosen intervention or pathway; and (b) their intended aim and anticipated outcomes pursuant to their participation in the Challenge.

Stories must meet the following requirements:

- a maximum of 300 written words or maximum of 3 minutes recorded video submitted in acceptable file format (for example, Mp4)
- demonstrate that their current and intended work falls within one (1) of the six (6) Indicators (i.e., the thematic areas Per Table 1, Section 7);
- describe the intervention(s) or pathway(s) (as set out in Section 5) being applied to achieve progress against one (1) or more of the six (6) Indicators (i.e., thematic areas per Table 1, Section 7);
- include a quote from at least one user (either provider and/or user) about how the intervention(s) or pathway(s) (as set out in Section 5) has affected, or will affect, their experience and/or practice as a clinician or healthcare provider. They must be explicitly identified by name and role in the story.

Stories received by the deadline above will be judged by HEC and given a score (a "**Story Score**") based on the following weighted criteria: (1) having met the requirements above (50%); and (2) creativity/originality (50%). Each Story must achieve a threshold Story Score of at least 75% (the "**Threshold Story Score**") (as determined by HEC in their sole and absolute discretion) in order to be eligible to receive an Innovation Description Award. In the event of an exact tie based on the foregoing, then a new panel of judges will be appointed by HEC to break the tie in accordance with the preceding procedures.

### **Dinosaur Pitch Challenge**

By March 29, 2024 at 11:59 p.m. ET, a Team representative from the Teams with the then (10) highest Dinosaur Mini-Challenge Scores will be invited to present to a live audience, convened by HEC, of up to one hundred (100) peers (in person and/or virtually), using a presentation format provided by HEC with timing, formatting and word count specifications, identifying and sharing their Dinosaur Plan and outcomes to date (**"Dinosaur Presentations**"). Dinosaur Presentations must be in English or French.

Each Dinosaur Presentation conducted by the deadline above will be judged by HEC and given a score (a "**Dinosaur Pitch Score**") based on the following weighted criteria:

Each Dinosaur Presentation must achieve the Threshold Submission Score (as determined by HEC in its sole and absolute discretion) in order to be eligible to receive a Dinosaur Pitch Den Challenge Award (as defined below). Each Team that makes an eligible Dinosaur Presentation that obtains one (1) of the top three (3) Dinosaur Pitch Scores (and satisfies the Threshold Submission Score) will be eligible to receive a dinosaur pitch award (each, a "**Dinosaur Pitch Award**") in accordance with the following:

In the event of a tie between two (2) or more presentations based on Dinosaur Pitch Scores, then the Team associated with the presentation that obtained the highest Dinosaur Pitch Scores on Criteria 6 criterion will be selected as the eligible recipient of the applicable Award. In the event of an exact tie based on the foregoing, then a new panel of judges will be appointed by HEC to break the tie in accordance with the preceding procedures.

## **Overall Retention Achievement Awards:**

By July 31, 2024 at 11:59 p.m. ET, Team Leaders can submit a maximum five (5) page report (the "**Overall Report**") using the template provided by HEC with formatting and word counts specifications demonstrating clear and measurable improvements within the Stream associated with the Team's overall participation in the Challenge. Reports must be in English or French.

In relation to each Stream, a panel of Judges appointed by HEC will judge and assign a score (a **"Total Overall Retention Achievement Award Score"**) to each Overall Report on the basis of the following weighted criteria:

- grants to HEC, in perpetuity, a non-exclusive, royalty-free license to publish, display, reproduce, modify, edit or otherwise use the Submission Materials, in whole or in part, for administering or promoting the Challenge (including, but not limited to, by posting such information on the Portal);
- waives all moral rights in and to the Submission Materials in favour of HEC (and anyone authorized by HEC to use such Submission Materials);

By participating in the Challenge, each Team Leader, Site Leader (on their own behalf and on behalf of their Site) and Team Member hereby warrants and represents to HEC that any and all Submission Materials submitted in this Challenge:

- i. are original and/or that all rights have been properly obtained in and to such Submission Materials for the purposes of submitting such Submission Materials in relation to participation in the Challenge;
- ii. do not violate any law, statute, ordinance or regulation;
- iii. do not contain any reference to or likeness of any identifiable third parties, unless consent has been obtained from all such individuals and their parent/legal guardian if they are under the legal age of majority in their jurisdiction of residence;
- iv. will not give rise to any claims whatsoever (including, but not limited to, claims of infringement, invasion of privacy or publicity, or infringe on any rights and/or interests of any third party); and

Teams reserve the right to conduct public communications, announcements, events, outreach and promotional activities about the Team's participation in the Challenge. Without limiting the generality of the foregoing, where a Team elects to engage jointly with HEC to conduct public communications, the Team Leader will give HEC ten (10) business days advance notice and advance copies of public communications related to the Challenge.

Both HEC and the Team shall receive the appropriate credit and visibility when information about the Challenge is communicated to the public. HEC's role in leading the Challenge, providing funding through the Awards and supporting improvements in selected Indicators will be acknowledged through appropriate written, verbal and/or visual identity.

In recognition of the Government of Canada's financial contributions to HEC, which all Teams acknowledge are used to support this Challenge, both HEC and the Teams agree the Government of Canada may disclose its role related to the Challenge without consent of any other party.

Notwithstanding anything to the contrary in these Terms, each Team Leader, Site Leader (on their own behalf and on behalf of their Site) and Team Member acknowledges and agrees:

- that HEC may share with the Government of Canada copies of any Submission Materials submitted in relation to the Challenge;
- that HEC and/or the Government of Canada may publish the fact that HEC and/or the Government of Canada contributed to the funding relating to the Challenge;
- that all research conducted involving individuals, shall include a research protocol that is consistent with the principles set out in the Tri-Council Policy Statement: Ethical Conduct for Research Involving Humans ("**Research Protocol**"); and
- to disclose any information reasonably requested in relation to the Challenge by HEC, its representatives and/or the Government of Canada, and to do so in a timely manner in the form and format requested.

Further, each Site Leader shall, and shall cause its Site to, maintain and keep appropriate records of all Research Protocol and provide HEC and/or the Government of Canada with a copy, if requested.

Team Leaders should identify at the Registration stage if they have determined that ethics board approval is or may be required. If applicable, plans to attain ethics approval must be described and factored into the Registration.


